## **Talking Points**

In April, Robert F. Kennedy Jr. delivered a powerful speech arguing for vaccine choice on the steps of California's capitol building in Sacramento, decrying the lack of strong regulations on the pharmaceutical companies that make vaccines. Below are some key points Kennedy makes during his speech.

- Mercury from vaccines is the largest exposure of mercury to our children.
- The CDC is corrupt and has fallen under the influence of our trillion-dollar Big Pharma industry. Rather than protect public health, the CDC seems to be serving the commercial interests of the vaccine industry.
- In 1986 the pharmaceutical industry was given, by Congress, immunity from lawsuits. Suddenly vaccines became very profitable. Vaccines started getting added to the schedule. Currently children are receiving 49 doses of 14 vaccines before the age of 6 and 69 doses of 16 vaccines by 18. No legal consequences and big money, why not?
- The federal government orders people to buy these vaccines. There is no advertising, no market, the patents don't expire and they can't be sued. They aren't being held accountable.
- The safety of the vaccines are decided by scientists on the advisory committees, the majority of which are financially entangled with the vaccine companies. One major example is Dr. Paul Offit, "a vaccine industry tycoon and insider, the principal promoter of vaccines in this country for the vaccine industry, who is on the vaccine industry payroll, in 1999 sat on the committee that approved [and added] the rotavirus vaccine to the schedule. At the time, he was working on his own rotavirus vaccine. Opening that gateway by adding that vaccine to the schedule made his patent extremely valuable. And six years later he sold that patent for \$182 million and pocketed about \$40 million himself." (p.11)
- The people approving the vaccines to be added to the schedule are the same people getting paid big bucks for the vaccines themselves. Are we to believe that our child's safety is their top priority?
- Dr. William Thompson, a senior scientists at the CDC, has publicly said that scientists working to test the safety of the vaccines have been required by their bosses to lie, manipulate and bury

data that connects neurological disorders, including autism, to thimerosal exposure and to vaccines.

- "All of the checks and balances in our society that normally would protect children from a rapacious industry have been neutralized." (p. 12) The pharmaceutical industry has complete possession of our politicians at Capitol Hill.
- There is a vaccine court. It's a secret court that doesn't advertise. When you sue, you're not suing the pharmaceutical companies, you're suing the federal government. Only about 10% of the people who have been injured and can make claims actually show up at the vaccine court. They have paid out \$3 billion to thousands of people who have been injured by the vaccines.
- "So you have the politicians that have been neutralized, you have the regulatory agency neutralized. You have the courts and lawyers gone. What's left? The press." (p. 13) Pharmaceutical companies are the biggest advertisers on TV, radio and in newspapers. Think the press will cover this issue honestly?

Whether you are "pro-vaccine" or "anti-vaccine" doesn't matter; what matters are safe vaccines for those who choose to use them.

Are we really supposed to trust a product that is so wrapped up in itself? There is a ton of money, legal security, and no advertising. Who is being held accountable?
